As part of my responsibilities as a Board member:

- 1. I will interpret the organization's work and values to the community, be willing to represent the organization, and act as a spokesperson on specific issues.
- 2. I will attend at least 75% of Board meetings, committee meetings, and special events.
- 3. Each year I will make a personal investment of my time, skills, finance or other type of contribution, at a level that is meaningful to me.
- 4. I will actively participate in one or more activities, to the best of my abilities.
- 5. I will act in the best interests of the organization, and excuse myself from discussions and votes where I have a financial conflict of interest.
- 6. I will stay informed and attempt to review information contained in the Board packet prior to attending Board meetings. I will participate in and take responsibility for making decisions on issues, policies and other Board matters.
- 7. I will work in good faith with staff and other Board members as partners towards determining and achieving this organization's goals.
- 8. I will abide by all existing Policies and Agreements adopted by the Board of Directors, including but not limited to the Conflict of Interest Policy.
- 9. If I don't fulfill these commitments to the organization, I will expect the Board President to call me and discuss my responsibilities with me.

In turn, the <u>organization will be responsible</u> to me in several ways:

10. I will be sent, without request, semi-annual financial reports and regular updates as needed of organizational activities and projects that allow me to meet the "prudent person"1 standards of the law.
